Conducts a risk analysis for legality and then deforestation assessment, prepares DDS and submits due diligence statements automatically.

Sourcemap

Traceability tool with Geo-Data Validation. Plots of land linked from suppliers in bulk and contains a validation tool re deforestation-free status and reporting. Uploads to the EU Traces platform and captures the reference number needed to clear customs. Supply chain mapping software allows visibility, verification and transparency.
