ATIF will process your application and issue with an invoice for your supporter status. Once paid, you will be included in all relevant resources and correspondence as a supporter.

ATIF supporters are individuals, companies or associations that intersect with timber industry. This includes timber importers, overseas exporters, customs brokers, transport and logistic companies, consultants, industry associations and other industry partners.

Importers that are not current ATIF members can use supporter status as a first step towards applying for ATIF membership.

Supporters will be suited to:

- importers without structures in place or size of business to meet the ATIF membership criteria
- individuals associated with the timber industry
- exporters or suppliers located outside Australia
- consultants and industry associations
- Customs Brokers and Transport Logistic companies
- · Retail merchant chains or groups





## WHAT A SUPPORTER STATUS INCLUDES

Your status as an ATIF Supporter means you will receive:

- Access to ATIF education sessions and resources
- Member bulletins and general member alerts
- Consolidated industry information that can be used to inform your business decisions
- Support material to cover all aspects of importing compliance
- Advocacy on behalf of industry to relevant Government bodies or industry regulators
- (for exporters or suppliers) introduction/advertisement to the members of ATIF and associated supporters of the products you want to sell.
- (for retail Merchant Chains & Groups) advice regarding who can supply particular products, intended uses etc supply chain assistance

Your status as an ATIF Supporter does **not** include:

- The ability to participate in the governance of ATIF, including voting rights in AGMs, SGMs or other critical functions, such as sitting on the Committee of Management
- The use of the ATIF logo (which is restricted to members)
